Subject **Regarding Central Governemnt Emplyoee status**

Most respected Hon'ble Lordship,

With profound respect, It is submitted to the Honorable Lordship that we are state employees working in the District Court of India whose administrative control is the High Court located in the state. By the Hon'ble Supreme Court's order dated 7.10.2009 in Civil Writ Petition No. 1022/1989, we were granted various benefit recommended by the First National Judicial Pay Commission (J. Shetty Commission) in 5th Pay Commission which has been extended in every future Pay Commission vide order dated 16.03.2015. It was also mentioned in the order that if the state government does not comply with the order, then the employees can file a petition in their High Court and the concerned High Court will dispose of the said petition within 3 months.

The recommendations of the First National Judicial Pay Commission (Justice Jagannath Shetty Commission) have not been fully implemented in any State of India till date despite the clear order of the Hon'ble Supreme Court and the final disposal of the writs filed by the employee Association by the concerned High Court has not been disposed off. In the hope of justice, our colleagues are retiring every year and many colleagues have also passed away. Despite being state employees, being under the administrative control of the High Court of our respective state, we are neither getting all the benefits that state employees get, nor are we getting the benefits that High Court employees get.


The biggest reason why the employees working in the District Courts are not able to get the immediate benefits of the orders of the Hon'ble Courts is our hung-over status due to which our benefits keep grinding between the State Government and the High Court and we are only forced to wait. We deserve a clear status either fully State government employee or high court's employee.

As a central body of the employees working in the District Court of India, the Association makes a solemn request with folded hands to the most respected Honorable The Chief Justice, Supreme Court to declare us central employees under the existing administrative control of our respective High Courts, so that the benefits we get judicially like the officers, it can be obtained with at a quick pace without any further judicial proceedings.
